### **OFFICIAL CONTEST RULES**

The contest is sponsored by Farm & Food Care. The contest is open to Canadian residents only and participants must be at the age of majority or older at the time of the entry. No purchase is necessary. Void where prohibited by law. Entry in this contest constitutes acceptance of these contest rules (the "Contest Rules")

1. ELIGIBILITY. To be eligible for this Contest, an individual must:
  - a) be a legal resident of Canada
  - b) be of the age of majority or older at the time of entry;

### **2. CONTEST PERIOD**

The contest begins November 10, 2020 and ends at December 5, 2021, noon EST. All entries must be received on or before the time stated during that submission period. Sponsor reserves the right to extend or shorten the contest at their sole discretion.

### **3. HOW TO ENTER**

There is no purchase necessary to enter the Contest. Your full name, email address and phone number is required. All entries must be submitted electronically from the contest website.

Entries are limited to one (1) per person. In the case of multiple entries, only the first entry will be considered. All entries become the sole property of Farm & Food Care. All entries must be received during the Contest Period. Entries will be declared invalid if they are late or incomplete.

Entries received online will be deemed to be submitted by the authorized account holder of the e-mail address associated. For the purpose of the Contest Rules, "authorized account holder" of an e-mail

address means the natural person who is assigned to an e-mail address by an internet service provider, online service provider or other organization responsible for assigning e-mail address for the domain associated with the submitted e-mail address.
